Our Community & Minority Business Development Program has been at the forefront of supporting minority business owners and entrepreneurs – whether it's financing through our Access Loan Program, connecting to local procurement opportunities, or educational opportunities through its Money Smart classes. In late January, Commerce Lexington was recognized with the 2022 UNITY Award from the Alpha Beta Lambda Chapter of Education Foundation of the Alpha Phi Alpha Fraternity for carrying out the legacy of Dr. Martin Luther King, Jr. and going above and beyond the call of duty in working toward unifying our community. There is still much work to be done in the DEI space, but our community has taken some important steps in the right direction.

In May, about 150 Central Kentucky leaders studied the Tampa-St. Petersburg, Florida region during the 2022 Leadership Visit. Our delegation had the opportunity to interact with many great speakers, while learning about things like housing affordability, regional collaboration, equity, talent development, placemaking and more. These annual intercity visits enable participants to see firsthand what works well and maybe not so well in other communities, so that we may leverage that experience to enhance things here at home.

Taking it a step further, many of the most successful communities Commerce Lexington has visited have strong regional partnerships and shared policy priorities that drive business and community leaders in a common direction. Regions that work together effectively toward common goals are better positioned to successfully navigate the challenges of the future.

For the last couple of years, an Economic Leadership Steering Committee comprised of public and private sector representatives from our nine-county economic development region developed a Competitiveness Plan for Central Kentucky. The final report includes several recommendations and action items focused on economic development, talent recruitment and retention, and regional leadership development.

Leaders from across the region recently gathered at the Regional Summit to learn how we can make Central Kentucky more economically competitive for jobs and talent. In a post pandemic world where businesses and people can live and work from almost anywhere, building a stronger region has never been more important.

Like many regions, we have a huge challenge in front of us to address our workforce challenges. Kentucky has the lowest workforce participation rate among its neighboring states, so we must continue to seek innovative solutions to skills training and talent recruitment. Earlier this year, the Business & Education Network partnered with the Lexington Fayette Urban County Government, Bluegrass Community & Technical College (BCTC), CHI Saint Joseph Health, Baptist Health and UK Healthcare to launch "Accelerate Lexington," a fully paid Certified Nursing Assistant (CNA) training program for selected candidates. This initial eightweek pilot program was a response to the healthcare worker shortage in Kentucky and resulted in 15 participants now employed by area hospitals. Many more ideas and programs like this will be necessary to further strengthen our workforce.

As I close my time as Board Chair, I want to take this opportunity to thank the staff, board, and many of you within our membership who have made Commerce Lexington effective and unified in its mission to increase business success and economic prosperity across our community. The organization will be in great hands with Cassidy Rosenthal from Stites & Harbison at the helm in 2023, and I look forward to what we will accomplish together in the future.
