Message from Board Chair Steve Byars

"We're better together."

Those words have been true throughout our history. They have gotten us through some challenging times here in Lexington. They are even more applicable today as our ninecounty economic development area continues to collaborate on a regional economic strategy aimed at making Greater Lexington more competitive for jobs and talent.

Successful companies collaborate across county lines and other markets, and successful regions are doing the same thing to strengthen their position across the country and around the world. We've studied regional collaboration time and again as we travel to other places during our intercity Leadership Visits. Collaboration is an absolute must, because the stakes are high, and competition is fierce among the top regions nationwide.

For Commerce Lexington, the Regional Competitiveness Strategy is the single most important initiative our team is working on. The plan has big goals to increase jobs, wages, and our labor force – specifically young professionals – to at least the national average over the next four years. To achieve this, regional leaders agreed on seven specific action items focused on economic development, talent recruitment and retention, and public policy advocacy.

Collaboration among economic development professionals across our region has been going on for decades through the Bluegrass Alliance, which helps ease the expansion or relocation process for companies looking to grow here. The idea is that no matter where a project decides to locate, there are substantial direct and indirect economic impacts for all the communities in the region. The Regional Plan supercharges that collaboration to the next level with business, education, and government leaders all working toward common goals.

In 2024, Commerce Lexington will continue to be an advocate for your business as the 60-day Legislative Session of the Kentucky General Assembly convenes in January. We'll be working with our regional partners to advocate for things that will help advance the Regional Plan goals, other pro-business policies, and those that help our higher education institutions and specifically the University of Kentucky as our region's primary economic driver.

We must continue to stay engaged in the discussions about the Comprehensive Plan in Fayette County, land use policy in general, and the urban growth expansion plan. We've seen what happens without a proper plan for growth over several decades. It's led to rapidly rising housing costs, dangerously low housing inventory, and increased inequity across our community. We must utilize all growth strategies available, including infill and redevelopment and when necessary, adding land that can help businesses create more jobs, increase housing stock, and attract much needed talent.

One of the most valuable things Commerce Lexington does each year is lead a delegation to visit and study another city during its Leadership Visit. These communitybuilding trips bring business and community leaders together to make positive changes in our community. This year, we'll travel to Salt Lake City, Utah (June 5-7) with a primary focus on learning about their ecosystem that helps commercialize intellectual property generated at the University of Utah.

I am very passionate about this organization, and I am excited to serve as your Board Chair for 2024. I encourage you to participate where you can and engage in issues that will help strengthen Greater Lexington for the next generation.



Growing the Greater Lexington Region's Life Sciences Industry

On December 6th, Commerce Lexington hosted a networking and strategy meeting with existing life science companies working in the area along with partners at the Lexington Mayor's Office, UK Innovate, and UK Coldstream Research Campus. Partners shared information about available resources designed to aid expansion efforts and grow existing companies. Commerce Lexington discussed the Comprehensive Regional Plan and details from the recent Targeted Industry Analysis which revealed favorable conditions for additional growth in life sciences including medical devices, ag bio, and biopharma. The group participated in a traditional SWOT industry analysis to help guide the growth strategy.





Commerce Lex.'s Gina Greathouse Presents at Aviation Symposium

Gina Greathouse recently participated in a panel discussion at the Aviation Symposium hosted by Kentuckians for Better Transportation, the Kentucky Aviation Association, and the Kentucky Department of Aviation. The session, moderated by Blue Grass Airport's Mark Day, focused on the significant role of airport access in economic development, shedding light on the numerous opportunities it brings to our region. The panelists' expertise and insights contributed to a thought-provoking discussion, exploring how the aviation industry can drive economic growth and prosperity in Kentucky.

Railroad 101 Informational Session

On November 17th, Commerce Lexington hosted a Railroad 101 session for the Bluegrass Alliance. A team of industry experts from R.J. Corman, Norfolk Southern and CSX Transportation networked with the group and spent time discussing the most important things economic developers need to know when it comes to railroads and industrial projects. The event was well received and offered a platform to ask questions and learn more about this safe and efficient mode of transportation.

E.D. Team Members Attend Economix Conference

Katie Vandegrift and Niki Goldey traveled to Atlanta November 28-30 to attend Economix. This fast-paced annual two-day conference brings together economic development professionals and top site selectors from across the country for valuable one-on-one time and deep dive conversations within specific industries. Additional presentations on workforce development, talent attraction and retention, and panel discussions that featured insights into current and future trends in site selection and how AI is affecting the practice rounded out day two. Throughout the conference, Katie and Niki made connections with 16 site selectors working in fields that have recently been identified as strategic industries well-suited for the Greater Lexington Region.

All regional partners shared updates on the Kentucky Product Development Initiative in their counties as well as information on available sites and buildings.

State Legislators Return to Frankfort for 60-Day Regular Session

On January 2, state legislators return to Frankfort to kick-off the 60-day Regular Session of the Kentucky General Assembly. The top priority for the 60-day Regular Session is passage of the FY 24-26 state Executive Branch budget and state road funding plan for transportation infrastructure projects. Special taskforces have met over the interim related to certificate of need, jail and corrections system reforms, local government annexation, multi-modal freight transportation, and health and human services delivery systems. Legislation is anticipated from those working group meetings. Some of the issues Commerce Lexington and regional leaders will be advocating for this session to support the Regional Competitiveness Strategy include:

State Tax Reform: Commerce Lexington has been supportive of the General Assembly's efforts to modernize the state's tax code by creating a process to lower the individual income tax over time by expanding the sales tax base. These changes have helped move Kentucky from #36 in 2018 to #18 in 2023 in the Tax Foundation's business tax climate rankings. This session, we will continue to encourage lawmakers to monitor the impact of tax reform and avoid adding any new taxes on business inputs that negatively impact competitiveness for jobs in key sectors and make Kentucky an economic outlier with how surrounding states treat businesses.

Local Government Tax Modernization: Commerce Lexington supports an amendment to the Kentucky Constitution, and enabling legislation, that would modernize Kentucky's local government tax structure. Kentucky's Constitution restricts local government taxes to three areas and does not allow for other options reflective of a changing economy like local sales tax. Commerce Lexington supports allowing the General Assembly the ability to create a new framework that provides more diverse options for revenue generation, and provides local communities with the flexibility to decide the local tax structure that works best to meet their unique community needs.

Kentucky Product Development Initiative: In 2022, the Kentucky General Assembly invested \$100 million in the Kentucky Product Development Initiative (KPDI) to help accelerate the development of more land and buildings for jobs across the state. For our region, KPDI funding is supporting 9 job site projects and \$30M in local and state investment. One of the competitive disadvantages for the Greater Lexington region is the lack of shovel ready land for jobs, and the development of a 500–1000-acre mega site. Commerce Lexington and regional leaders will ask legislators to continue to invest in the KPDI program and consider flexibility in eligible projects to include regional economic development marketing.

Talent Marketing Funding: Our region is lagging the national average in labor force growth, specifically the number of young professionals living and working in the region. Through the Regional Competitiveness Strategy, regional leaders are working to attract and retain 1,500 more young professionals each year by elevating marketing to targeted cities and increasing job connections for students. Many states are making investments in talent attraction marketing efforts to amplify messaging

about quality of life and job opportunities. Commerce Lexington supports the General Assembly investing in funding for a talent attraction marketing grant program to help support regional economic development.

Housing Affordability: Rapidly rising home prices combined with low inventory in Fayette County and the region are pricing families, essential workers, and first-time homebuyers out of the market. Providing adequate levels of housing to meet the needs of the region's workforce is an issue of concern for expanding and relocating companies and the attraction of young professionals. At the state level, Commerce Lexington will support efforts to increase funding for housing affordability projects for Lexington and the region, including advocacy to the Kentucky Housing Corporation to ensure Lexington can more fairly compete for those resources based on the unique challenges of the community such as land availability. We also support the General Assembly allocating additional funding to support affordable housing projects aimed at meeting the missing middle or workforce housing needs.

Transportation Funding: Thriving communities must be able to move workers, provide services and transport products to market quickly and safely. Commerce Lexington supports a regional transportation approach, and continued state investments in critical road, rail, and air infrastructure projects within the nine-county region to improve interconnectivity and access. We support modernizing the transportation funding distribution model to make it more equitable for areas with higher levels of transportation activity and needs. Commerce Lexington further supports modernizing the funding infrastructure to better reflect the current state of transportation as well as anticipate future needs of our transportation systems.

Education Funding: Commerce Lexington supports the General Assembly's continued investments in public K-12 and higher education to support economic development and workforce development in the 9-county region. This includes investments in capital projects, performance-based funding model, work-ready scholarships, dual credit scholarships, and training programs.

The 2024 Regular Session is scheduled to conclude on April 15. Commerce Lexington urges members to stay connected on state, local and federal policy issues during the year. Regular email updates will be provided to members throughout the year to keep businesses updated on what's happening in City Hall, Frankfort and Washington, D.C. and the impact on the Greater Lexington region.

Labeled as the Silicon Slopes, Salt Lake City is home to a buzzing tech scene - between that and the other booming businesses in the city, its downtown area has been brought to life like never before. From a top-shelf performing arts scene, to award-winning dining, craft beer, and distilling culture, this Old West town has become a forward-thinking, and burgeoning urban hub. There will be a lot for us to learn during this trip - from Salt Lake's thriving tech industry to its exceptional quality of life and efforts in the talent attraction space. It is also home to the Huntsman Cancer Institute, a nationally-recognized cancer hospital and research center and benchmark institute for the UK Markey Cancer Center.

This state capital city has a growing number of IT, finance, outdoor products, and manufacturing companies capitalizing on the area's strategic location as the "Crossroads of the West." Ranked as one of the best environments for business, the Salt Lake area's concentration of biomedical, high

tech, and software firms is among the highest in the nation.

Since 2019, the city has seen a hefty 12-percent increase in tech talent to nearly 67,500 tech jobs, outpacing the national average in tech job growth over that same period. Although there has been a rapid acceleration of the tech industry in recent years, software companies like Novell and WordPerfect got their start in Utah in the late 1970's.

The city is home to University of Utah, the state's flagship university with over 31,000 students, and one of the top 25 business and entrepreneurship schools according to the *Princeton Review*. The educated, multilingual, and ambitious workforce in Salt Lake City makes it an ideal location for top companies.



We learned about the meticulous breeding and training process that goes into producing top quality racehorses and came away with an increased appreciation and understanding of the impact that the industry has in Central Kentucky.

The next stop was the Paris-Bourbon County YMCA, serving the community since 1913. Drew Beckett, Executive Director/CEO, shared a brief history and the different programs offered for all ages. We toured the Teen Center, which opened in 2022, and has provided a safe and fun space for teens in Bourbon County. While visiting the facility we had the opportunity to hear about the Waste Transfer Station Relocation Project. A panel of city and county leaders discussed the project and the challenges and opportunities to revitalize an area in the West End of Paris.

Mustard Seed Hill was our next destination on our tour, located in Millersburg. Victoria Benson, President of Mustard Seed Hill, shared the vision of Community Ventures and then a brief history and how the campus is home to Mustard Seed Events, Bourbon Christian Academy, and several small businesses. All of which has had a tremendous impact on the Millersburg community.

The final stop of the day was the newly constructed Secretariat Park in downtown Paris. The park was a passion project for a small group of residents that understood the importance of celebrating the most famous Thoroughbred in history and his connection to Bourbon County.
